2023 Recap of BHCA Engagement

- Membership experienced significant changes due to moves in/out of neighborhood.
- Socials BHCA increased focus based on '22 membership feedback survey and events included 2 adult member only mixers, 3 neighborhood family park events, 1 membership dinner event, and 1 holiday event (upcoming).
- Beautification landscape maintenance is provided by BHCA monthly at Colonial & Standard bridge and roundabout and a shrub planting project on Colonial Bridge was completed. BHCA has engaged with the City on future bridge clean up and maintenance so as to protect aesthetics of our primary community entrance.
- Security Flock LPR cameras at Colonial & Standard owned by BHCA have been used in police investigations (details to be presented by Brookhaven Police) and the camera in Langford Park is scheduled for installation on o1/24. An off-duty police office was secured for community patrol.
- Pet Waste Management BHCA provided pet waste disposal bags throughout community via volunteer and BHCA board member efforts.
- Community Updates BHCA provided updates on City tax referendum, volunteerism, events, and safety issues impacting our community

 Sponsorship Process - is a new tool created by BHCA and secured resident donations for social events.

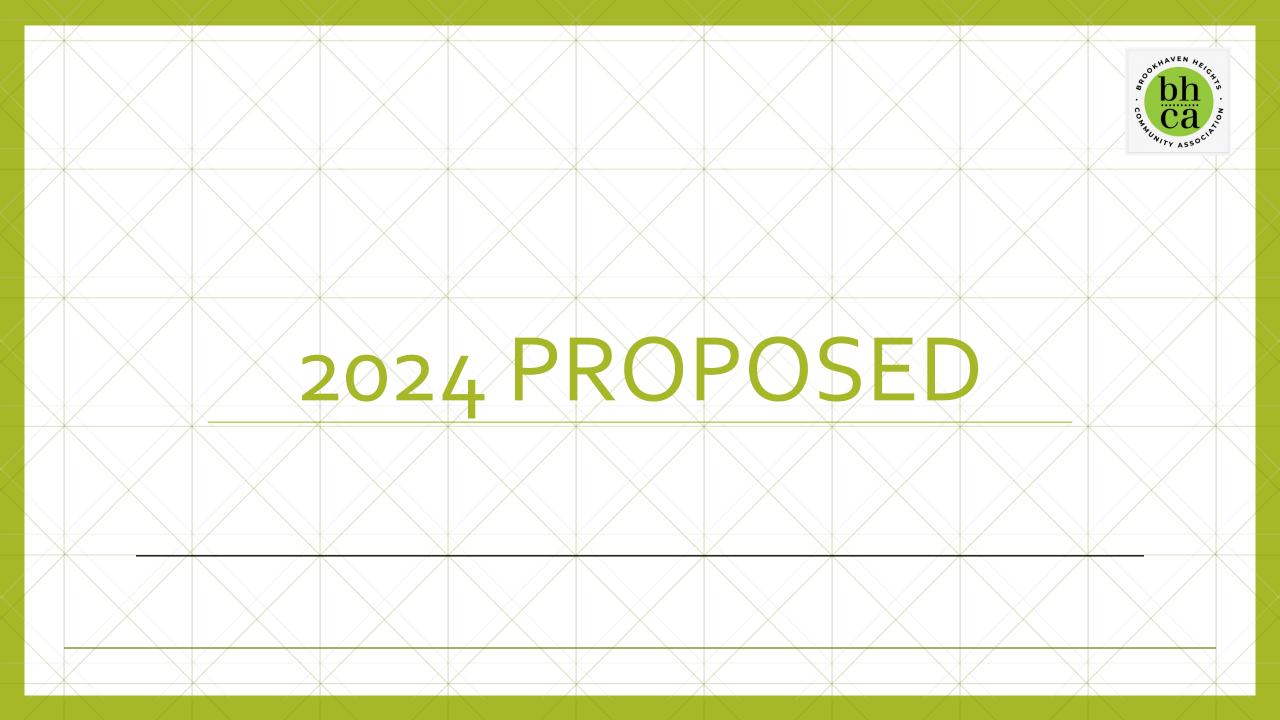

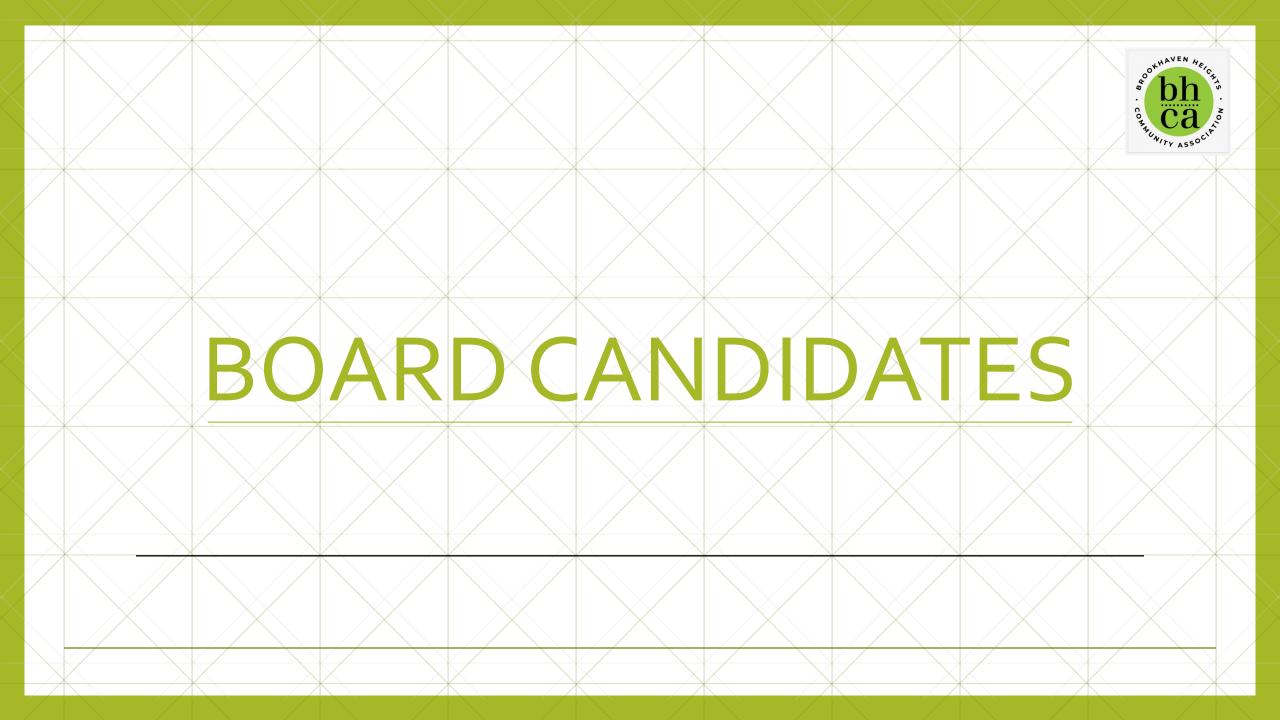

2024 Proposed Member Dues Structure

- Maintain April 1st as common renewal date for existing members, carrying membership through March 31st of following year
- Maintain current dues structure of: Family Household \$95 and Single Household \$50
- Maintain incentive to encourage new members:
 - New members joining in 1st quarter of will pay proposed due structure carrying their membership through March 31st of following year, resulting in up to 15 months of membership for the price of 12 months
 - New members joining after April will continue to have their memberships pro-rated to maintain a common renewal date with the rest of our membership
- Maintain 2023 socials, security, landscaping and communications.
- Approve a budget that provides the board aggregate spending authority as indicated with discretion across spend categories
- Conduct a target recruitment campaign via mail similar to that in 2022, to boost membership

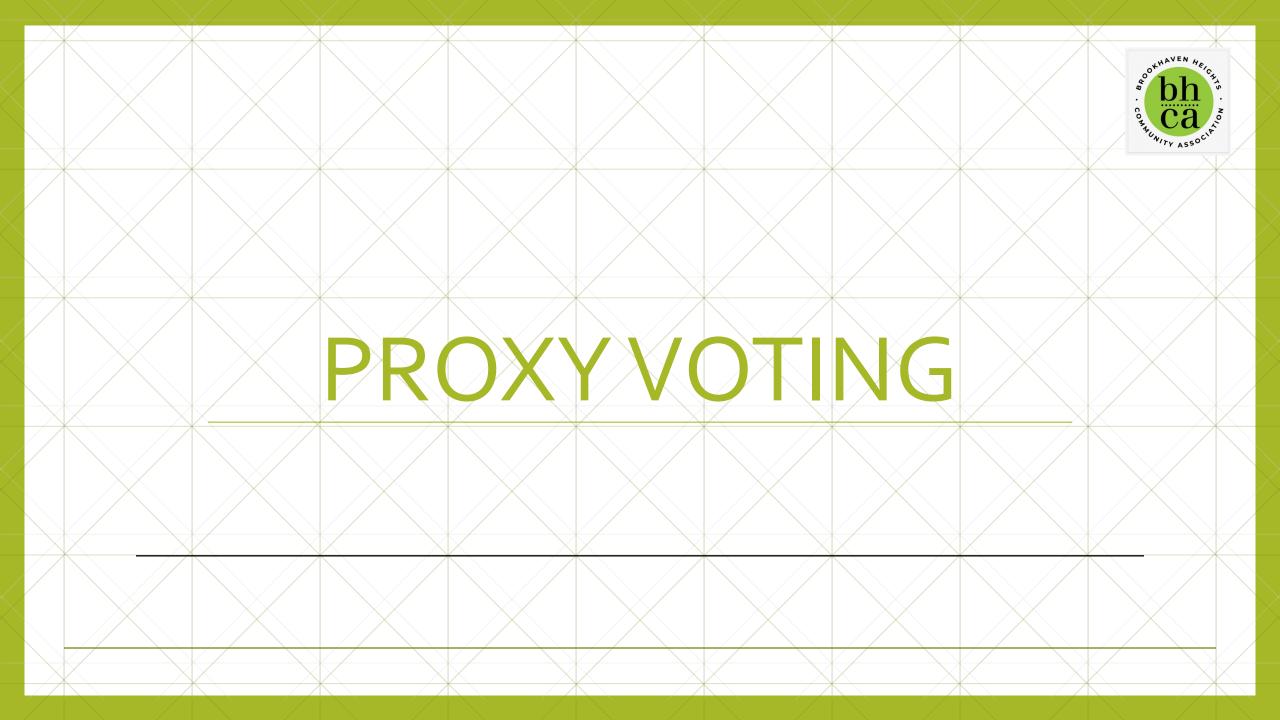

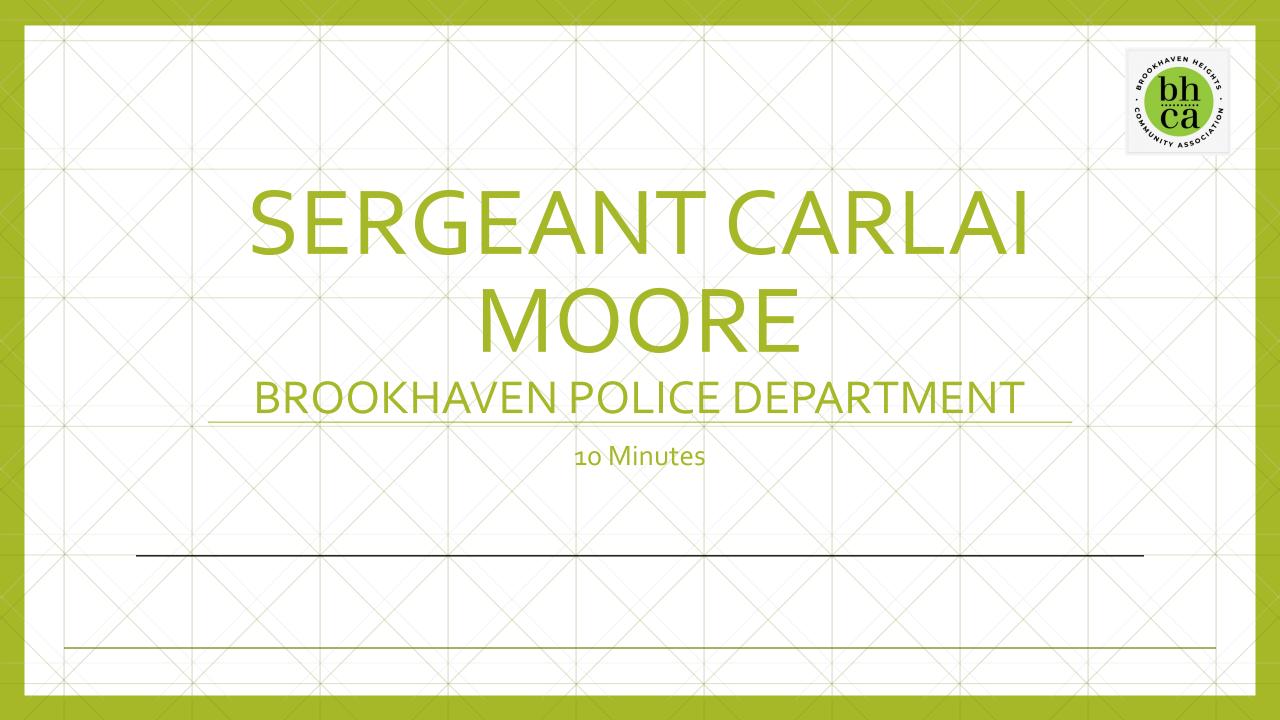
